The underlying premise in §§ 210.1 and 212.2 is that CGMP sets forth minimum requirements to assure that drugs meet the standards of the FD&C Act regarding safety, identity, strength, quality, and purity.<sup>4</sup> Requirements with respect to data integrity in parts 211 and 212 include, among other things:
